Update and quarterly report to the ISOC Board of Trustees Meeting on June 23rd 2024, on behalf of the Chapter Advisory Council (ChAC) Steering Committee (ChAC-SC)

ChAC-SC meetings are held monthly; since our last update, these have occurred, as shown in the table below. This year, the Leadership Team has continued the practice of holding a short prep call 1 week before each of our scheduled calls but additionally decided to advertise these calls to the remainder of the ChAC-SC, who are welcome to join; these are now also listed in our call scheduling document and are also in the table below-

As previously noted in our updates, the ChAC is continuing to find ways to improve the metrics associated with both the total number of chapters having appointments to the ChAC and to increase overall engagement. At this stage, we are tracking the attendees and looking for patterns that we can react to (note previous statistics were collected in 2023). We have included raw attendance statistics from our Full ChAC Representatives calls for Q1 and Q2 below, noting a slight increase in attendance for the Q2 call and a drop in the number of Chapters who have appointed a ChAC representative.

- → The 21 May 2024 Full ChAC Representatives call statistics were 39 ChAC Reps and 1 Observer from the Accessibility SG.
  - Total no of Chapters: 120,
  - ◆ Total no of Chapters with a ChAC representative appointed: 90 (75%),
  - Total no of Chapters without a ChAC representative: 30 (25%)
- → The statistics for the 20 Feb 2024 Full ChAC Representatives call were 33 ChAC Reps and 1 Observer from the Accessibility SG.
  - Total no of Chapters: 120,
  - Total no of Chapters with a ChAC representative appointed: 93 (78%),
  - Total no of Chapters without a ChAC representative: 27 (22%)

During the Full ChAC Q2 call, we engaged in

- A presentation and discussion facilitated by Ted Hardie and other BoT members regarding the 2030 Strategy.
- A follow-up from the Q1 call, where questions were raised regarding the geographic distributions of grants. The ChAC was presented with an informative and, we believe, useful presentation from the Internet Society Foundation facilitated by Sarah Armstrong and Jenn Beard, which included a Q&A session that has clarified many if not all the questions previously raised.

The ChAC thanks the ISOC Puerto Rico Chapter for initiating these proposals.

The first proposal is that the <u>Chapter Delegate email list</u> should be opened to Chapter members as observers (view only – not allowed to post) to enhance transparency and understanding of ongoing discussions concerning ISOC chapters.

The second proposal is that ISOC funding for the ISOC LIVE video services and archiving services should be reinstated, and ISOC LIVE should be financially supported by ISOC on an ongoing basis.
