From the CEO

In Zimbabwe, Innocent Sibanda, a member of the local Internet Society Chapter, noticed that networks in his region were insecure. In 2022 he enrolled in a six-week, hands-on networking course we offered and learned how he could ensure that people could get online safely. He went on to become a trainer himself and is now helping connect local schools and other organizations to the rest of the world.



The Internet changes lives. It opens up opportunities for people like Innocent and so many more. For those of us with access, the Internet has become woven into the fabric of our lives. We use it for everything. And for the third of the world without access, they are being left even farther behind.

In 2024, the Internet Society Board of Trustees adopted our Strategy 2030, laying out a five-year vision with two strategic goals:

- 1. People everywhere have access to affordable, reliable, and resilient Internet
- 2. People everywhere have an Internet experience that is safe, secure, and protects them online.

The focus on people is critical. We must remember that every encrypted connection helps protect someone's private information. Every new Internet exchange point adds resilience that ensures that a business remains online. Every new community network unlocks opportunities for a child or a family in that community. Our work may involve technology, but ultimately, it is about changing people's lives for the better.

The following Action Plans for both the Internet Society and Internet Society Foundation outline our priorities in 2025, the first year of our five-year strategy. These priorities demonstrate our collective ambition to ensure that the Internet is a resource that enriches people's lives and is a force for good in society.

We can't do this alone – it will take all of us. If we are to achieve our vision that the Internet is for everyone, we need to unite to be the voice that the Internet needs.

Over 2 billion people have zero or insufficient Internet connectivity; these people are the hardest and most expensive to reach.

To address this, the Community-Centered Connectivity program seeks to support community-centered connectivity for marginalized and underserved populations by (a) providing easy, sustainable solutions and (b) advocating for policies that support community-centered connectivity.







Over the next five years, we will:

- **Invest in local communities** so they can establish and sustain their own connectivity;
- **Bring connectivity** to vulnerable populations including Indigenous communities, women-led enterprises, and refugees;
- Advocate for policies and regulations that enable community-based connectivity models to thrive;

- Scale impact through partnerships, community, fundraising, and impactful giving; and
- · Create positive and enduring **impact**, including:
 - Meaningful connectivity for more people;
 - Favorable policy outcomes; and
 - An empowered and mobilized community that promotes community-centered connectivity.

2025 Priorities

- Improving and scaling our approach to supporting community-centered connectivity;
- Helping people connect to the Internet by identifying and promoting simple and easy connectivity solutions;
- · Delivering training and strengthening local technical communities so they can maintain and defend the Internet; and
- **Providing grants** and advocating for policies that support community-centered connectivity.

Access is more expensive and unreliable where Internet interconnection infrastructure is weak or lacking.

To address this, the Affordable and Reliable Access program seeks to make access affordable and resilient for marginalized and underserved populations by (a) improving local Internet interconnection infrastructure and (b) advocating for an enabling policy environment that supports a thriving digital ecosystem.





Over the next five years, we will:

- Provide equipment and training to support
 the development of sustainable community-led
 Internet Exchange Points in Least Developed
 Countries and Small Island Developing States;
- Demonstrate with evidence that local traffic contributes to more reliable and affordable Internet;
- Advocate for policies and regulations that enables community-led infrastructure to thrive;
- Scale our impact through partnerships, community, fundraising, and impactful giving; and
- Create positive and enduring impact, including:
 - More affordable Internet;
 - More reliable Internet;
 - Favorable policy outcomes; and
 - An empowered and mobilized community that advances the Internet's resilience and affordability.

2025 Priorities

- Continuing to improve and scale our approach to supporting local peering infrastructure, with focus on Small Island Developing States and Least Developed Countries and
- Strengthening local peering infrastructure
 through training, providing grants, advocating,
 improving materials and resources, and
 strengthening local technical communities.



Without access to knowledge and resources, newly connected people, especially marginalized and underserved populations, face a higher risk of safety and security threats during their online experiences.

To address this, the Online Trust and Safety program seeks to (a) equip recently connected people with knowledge and skills to protect themselves and their communities online; (b) to advocate for choices made by commercial and government decision-makers that prioritize safety, security, and privacy; and (c) to equip our chapters with tools and resources to promote online safety in their local communities.





Over the next five years, we will:

- Co-create an online safety program with the Internet Society community that responds to local needs, challenges, and opportunities;
- Curate and exchange online safety knowledge and resources with our community and partners;
- Integrate practical online safety skills resourcing and training into all Internet Society programs targeting the newly connected, particularly Indigenous groups, refugees, and women-led social enterprise populations; and
- · Create positive and enduring **impact**, including:
 - Safer online experience;
 - Favorable policy outcomes; and
 - An empowered and mobilized community that supports people's online safety, security, and privacy.

2025 Priorities

- Developing diverse partnerships with leading experts, including the Accessibility Standing Group, chapters, partners, and alumni, to co-create innovative and sustainable approaches to helping people make safer online choices and
- Assessing needs as well as available online trust and safety resources.



Governments, courts, and commercial entities make decisions that weaken the Internet, which limit the potential of the Internet as a global public resource for social and economic opportunities.

To address this, the Open and Trustworthy Internet program seeks to empower policymakers, courts, decision-makers, and commercial entities with the knowledge and awareness to facilitate change. We will advocate for policies and practices that defend the Internet as an open and accessible platform for free expression and the exchange of ideas, safeguarding fundamental rights, ensuring the well-being of users, and fostering trust in digital technologies.



Over the next five years, we will:

- Enhance the influence of technical communities and expertise in Internet governance, using our ability to bring people together, and diplomacy to strengthen the collective voice of our community on important Internet matters and Internet governance;
- Support policies, regulations, legal, and commercial decisions that promote an open and trustworthy Internet;
- Oppose policies, regulations, legal, and commercial decisions that

- endanger the Internet and individual participation online;
- Provide support for our community to mobilize and advocate for issues that promote an open and trustworthy Internet; and
- Create positive and enduring **impact**, including:
 - Favorable policy outcomes and
 - An empowered and mobilized community that protects and defends an open and trustworthy Internet.

2025 Priorities

- Continuing our efforts to build powerful Internet technical communities and together respond to policy threats and opportunities to support an open and trustworthy Internet around the world:
- Positioning the Internet Society as a powerful voice and thought leader in the policy arena at national, regional, and global levels;
- Updating Internet Society **Policy Briefs** and crafting new ones as topics emerge;
- Training and engaging with officials from governments guiding the

- development of national and regional Internet policy;
- Strengthening the Internet Society's **position** as the trusted partner that will be the voice of the Internet in United Nation-led processes;
- **Informing courts** how the Internet works and the risks or benefits of laws related to the Internet;
- Fostering information exchange by hosting the Network and Distributed Systems Security Symposium; and
- Leading in-person community workshops focused on developing advocacy skills.

A thriving Internet ecosystem requires reliable data and clear standards to understand the forces shaping it. Without accurate data and cohesive standards, stakeholders cannot make informed decisions, leaving the Internet vulnerable to fragmentation and threats

To address this, the Internet Insights and Innovation program is focused on providing trusted, actionable data about the health, availability, and evolution of the Internet. It will also focus on standardizing information about terrestrial fiber optic networks to encourage widespread use of the standard.




Over the next five years, we will:

- Map terrestrial fiber optic infrastructure;
- Embed data insights within all Internet Society programs as well as advocacy, community mobilization, and fundraising efforts; and
- Create positive and enduring **impact**, including:
 - An empowered and mobilized community committed to evidence-based advocacy.

2025 Priorities

- **Expanding Pulse data library** and resources and improve Pulse user experience;
- Launching the Pulse supporters' **program** and sponsored research fellowships; and
- Initiating Open Fibre Data Standard (OFDS) work and developing a sustainable approach to the maintenance of the standard.



- Empowering a Talented Workforce **Driven by Innovation and Committed** to Inclusion
 - Our Internet Society and Internet Society Foundation staff spans over 30 countries, creating a diverse and dynamic global team. In 2025, we will invest in a human resource information system to simplify how we connect and support our people. This system will enhance data security, streamline everyday processes, and provide valuable insights, empowering us to make strategic decisions that enhance the employee experience, nurture engagement, inclusion, and growth for every member of our global team.
 - Aligned with our commitment to inclusion, we will take steps to more fully embrace a culture of accessibility by ensuring staff are equipped with the necessary knowledge and resources to ensure accessibility of the materials and resources we produce.
